

Qualifications

Applicants must have a high school diploma or GED equivalency, and be at least 18 and no more than 45 years of age.

Upon completion of a physical ability test a written test administered by the Kanawha County Deputy Sheriff's Civil Service Commission must be taken. Those passing the first rounds of testing will be required to undergo additional physical and psychological tests, including:

Training

Upon appointment, new Deputy Sheriffs will be required to complete a probationary period of one year. During the first year newly hired members will attend the WV State Police Academy for 14-16 weeks of classroom studies, physical fitness, defensive tactics, driver courses, and firearms training.

After graduation probationary Deputies will participate in a 4-phase, 14 week Field Training Officer (FTO) Program. The goal of the FTO program is to produce better-prepared, bettertrained officers. Through the FTO program new Deputies will learn to deal with the responsibilities of the career, while parterning with veterans of the agency.

The Kanawha County Sheriff's Office places a high emphasis on continued training throughout the careers of its Deputy Sheriffs.

Assignments

Upon completion of the FTO Program Deputy Sheriffs will be assigned their duties by the Sheriff.

Most will be assigned to Road Patrol answering 911 calls, investigating crashes and crimes. Some will be assigned to Judicial Services to bailiff courtrooms and secure the courthouse.

Responsibilities

A Kanawha County Deputy Sheriff may generally be given an assignment with regular hours and duties. But Deputies may be called to duty at all hours, particularly those with special training.

Law enforcement officers must maintain a high state of readiness, mentally and physically, to meet the demands of the job. They must cultivate partnerships in the community, and put others ahead of themselves.

Deputy Sheriffs must be diligent, respectful, courteous, and courageous. They are required to solve problems, document their actions, talk to witnesses, arrest suspected criminals, communicate with the public, and make complex decisions quickly.

The responsibilities are great. The great reward is the satisfaction of giving your time, effort, and abilities in service to your community.

Application Process

Applications may be obtained at the Kanawha County Clerk's Office at 407 Virginia Street East, Charleston WV, on the first floor of the Kanawha County Courthouse. Completed applications must be filed with the County Clerk's Office, after which the Applicant will be notified by certified US Mail when a test is scheduled. The mailed notification, and an announcement in local newspapers, will include the date, time, and location of initial testing.
