# Double Murder Suspect from Pennsylvania Located in Kanawha County

**Charleston, WV**- On Monday, April 8<sup>th</sup>, 2024, Metro 911 received information just after 6:00 a.m., that a murder suspect from Allegheny County, Pennsylvania was possibly traveling towards Kanawha County on Interstate 79.

Dennis Rahuba, 50 years old, was wanted by Pennsylvania authorities in connection with a double homicide that occurred overnight in Allegheny County. Rahuba was reported to be traveling south towards Kanawha County in a black Acura with Pennsylvania registration.

Just before 7:00 a.m., Kanawha County Sheriff's Deputy J.A. Morris spotted the suspect vehicle on Interstate 79 at Big Chimney. Multiple deputies and surrounding law enforcement officials joined Deputy Morris as they attempted to conduct a traffic stop around the Westmoreland Exit.

The interstate was immediately shut down and the suspect vehicle was surrounded. Deputy Morris tried to lawfully order the suspect from the vehicle when he observed and heard what was believed to be a single gunshot.

Metro 911 Communicators had received warnings from Pennsylvania that Rahuba was believed to be armed with a firearm, so the Kanawha County Sheriff's Office deployed their "Bearcat" armored vehicle to the scene and closed all north and southbound lanes.

A team of Kanawha County Sheriff's Office SWAT members approached the vehicle and confirmed the suspect, Mr. Dennis Rahuba, was deceased from a self-inflicted gunshot wound.
